

Credit Guarantee and Investment Facility (CGIF), a trust fund of the Asian Development Bank (ADB), was established by the governments of 10 ASEAN countries and China, Japan and Korea (ASEAN+3), and by the ADB, as a key component of the Asian Bond Markets Initiative (ABMI) of the ADB and the ASEAN+3 cooperation. CGIF has been established to promote economic development and resilience of the financial markets, and to prevent disruptions to the international financial order by developing deep and liquid local currency and regional bond markets. The main function of CGIF is to provide credit enhancement to promote more issuances of local currency corporate bonds in ASEAN+3 countries.

JOB PURPOSE

The External Relations and Market Development Officer (ERMDO) is a locally recruited national staff position that will support CGIF's communications and market outreach initiatives. The selected candidate will be offered a locally competitive salary and benefits package.

EXPECTED OUTCOMES

The ERMDO will report directly and assist the Unit Head in leading CGIF's communications and market outreach initiatives, including developing and implementing its related strategy, work plan, and programs.

Responsibilities of the IRMDO consist of the following, among others:

- Building, maintaining, and leveraging a robust network of contacts across region, particularly
 with CGIF's Contributors, regulators, investment communities and the media to enhance the
 CGIF's image and branding.
- Creating, managing, and updating CGIF's website, platforms, and associated content to maximize market awareness.
- Organizing and co-organizing the relevant events, roadshows, panels, conferences to raise awareness and outreach.
- Tracking and evaluating effectiveness of media and market outreach.
- Perform any other relevant duties that the supervisor may assign on a case-to-case basis.

QUALIFICATION

Education Requirements:

A university degree in communications, journalism, international relations, economics, finance or related fields from a top university.

Relevant Experience and Skills:

- Minimum of 10 years' experience in public affairs and/or investor relations with a good understanding of financial markets.
- Experience preparing and implementing strategic communications plans in an international organization.

- Good knowledge of web/digital technologies and practices, and a good experience in applying them to advance an organization's communications objectives.
- Good understanding of current publishing, media, social media, and digital content environment and promotion strategies
- Must have excellent writing and verbal communication skills

- Skilled in written and verbal communication skills. This includes the ability to craft clear and compelling messages for various stakeholders, including CGIF"s contributors, regulators, investors, analysts, and the media.

- Skilled in using investor relations platforms and technologies. This may include tools for managing investor databases, communication platforms, and analytics tools for monitoring social media and market sentiment.
- Skilled at leveraging technology to streamline communication processes, enhances data analysis, and provides insights into investor behaviour and trends.
- Has a developing knowledge of financial markets in the ASEAN+3 region.
